

CAPLYTA withMe Trial Offer Program

30-day trial supply for eligible patients beginning treatment



Once prescribed, the Trial Offer is available for eligible patients to receive a 30-day supply at no cost to help you become familiar with CAPLYTA. At the conclusion of the trial period, you and your healthcare provider decide whether to continue treatment.

Subject to one (1) use per lifetime for your first 30-day supply of CAPLYTA. Terms expire at the end of each calendar year and may change. This Trial Offer is open to patients who have commercial insurance, government coverage, or no insurance coverage; however, there is no guarantee of continuous accessibility after the trial period ends. How to Use the CAPLYTA withMe Trial Offer

- 1 Once you receive a Trial Offer from your doctor, bring the card and your signed 30-day prescription for CAPLYTA to your pharmacist to receive a 30-day supply at no cost.
- 2 If for any reason your pharmacy cannot process your card, you may still be able to receive a rebate by completing and returning a **Rebate Form** by fax or mail.

Trial Offer Program Requirements

Am I eligible?

You may be eligible for the CAPLYTA withMe Trial Offer Program if you are age 18 or older and have been prescribed CAPLYTA for an FDA-approved, on-label indication. The Trial Offer is available for eligible patients to receive a 30-day supply at no cost to help you become familiar with CAPLYTA.

Other requirements

- Patients enrolled in a Medicare Part D plan are eligible for this free 30-day trial offer but may not submit a claim for the costs paid by this program to count toward true out-of-pocket (TrOOP) costs.
- Patients may not seek payment for the value received from this program from any health plan, patient assistance foundation, flexible spending account, or healthcare savings account.
- Offer good for use only with a new CAPLYTA prescription at the time the prescription is filled by the pharmacist and dispensed to the patient. No substitutions permitted. No purchase required.
- One (1) use is allowed per lifetime.
- Terms expire at the end of each calendar year. The program may change or end without notice, including in specific states.
- By using the Trial Offer, you confirm that you have read, understood, and agree to the program requirements.
- By using this offer, your personal information that may include your name, address, phone number, email address, and/or other information, including information related to your prescription medicine insurance and treatment will be collected. This information is needed for Johnson & Johnson Health Care Systems Inc., our affiliates, and our service providers to manage your enrollment in the CAPLYTA withMe Trial Offer Program.
